I. Call to Order

Chairman Kevin Louis called the meeting to order at 2:30 p.m.

V. Call to the Public

Chairman Louis opened the call to the public and announced that Hans-Dieter Cloes would like to provide comment. Chairman Louis acknowledged receipt of a letter from Mr. Cloes.

Hans-Dieter Cloes stated that he is aware of the County's plans to continue paving Florence-Kelvin Highway through the Big O Wash up to Cochran Road but there are 3 private properties to the west of the wash through which the road is crossing. According to the paperwork received when he bought the property in 1995, he was obligated to allow a 50-foot easement for the transgression of the road. Mr. Cloes further stated that he is okay with the current alignment of the road as long as it remains a dirt road. He expressed when paving is completed that would constitute a permanent loss of property and result in a property loss of 2.4 acres in his case and 2.8 and 5.6 acre losses for neighbors who live to the east of him. Mr. Cloes acknowledged that all property owners know that they have to allow a 50-foot easement but advised that the road is currently 68-feet wide. Mr. Cloes understands from his public records request, that it is planned to widen the road to 100-feet. He believes it is a burden to have a road through his property now but would be a greater burden once it is paved and widened. Mr. Cloes suggested to Transportation Department staff that realigning Florence-Kelvin Highway would cut the pain for losing their private property by one-half but received a negative response as of yet. He stated that shifting the road 70 to 100-feet to the south would benefit all parties involved.

VI. Discussion/Approval/Denial of Minutes from November 21, 2013

Vice-Chair Brown made a motion to approve the minutes from the November 21, 2013 Transportation Advisory Committee meeting as presented and Member Prechel seconded the motion. The motion passed unanimously.

VII. Presentation on the Southern Pinal Regional Corridors Study

Travis Ashbaugh, Public Works Senior Transportation Planner, provided a general overview of the Southern Pinal Regional Corridors Study. Mr. Ashbaugh stated that the study is jointly sponsored by Pinal County, the City of Eloy, and Town of Marana and is administered by Arizona Department of Transportation (ADOT) with assistance from Parsons Brinckerhoff. He continued to say that the study area is roughly bounded by Selma Highway to the north, Avra Valley Road to the south, Trekell Road to the west, and State Route 79 to the east. Mr. Ashbaugh expressed that funding for the study is provided from the Planning Assistance for Rural Areas (PARA) grant program managed by ADOT's Multi-Modal Planning Division. He also noted that PARA funds planning efforts for roadways and public transportation but it cannot fund design or construction of facilities. Mr. Ashbaugh stated that the purpose of the study is to evaluate and enhance transportation access to major employment centers and facilitate freight movement in the region. He explained that study is divided into 7 major tasks and followed with greater detail on each task item.

VIII. Transportation Project Status Reports on current and upcoming projects currently listed in the 2013 Transportation Improvement and Maintenance Program for Budget Years: 2012-2013 through 2016-2017

Public Works Area Engineers: Angeline To, Jeff Stolze, and Celeste Pemberton provided oral reports on current and upcoming projects listed in the 2013 Transportation Improvement and Maintenance Program for Budget Years: 2012-2013 through 2016-2017.

Copies of the reports are attached.

IX. Presentation/Discussion/Recommendation for the proposed 2014 Five-Year Transportation Improvement and Maintenance Program for Budget Years: 2013-2014 through 2017-2018 including recommended transportation projects and project amendments.

Kathy Borquez presented the proposed 2014 Five-Year Transportation Improvement and Maintenance Program for Budget Years: 2013-2014 through 2017-2018. She stated that copies of the proposed plan were distributed to the TAC electronically and by mail. Mrs. Borquez expressed that the plan is proposed until the TAC takes action to approve it and then it becomes a draft plan. Mrs. Borquez reminded the TAC that the plan is a recommendation until the Board of Supervisors approves it.

She further stated that two components influence change in the TIMP, project amendments and fifth year proposed projects. Ms. Borquez advised that amendments are status changes or project carryovers due to scheduling or funding constraints. She reiterated that target funding for the proposed projects was set at \$4.3 million with an additional \$1 million divided equally between the Safety and Pavement Preservation Programs.

Mrs. Borquez reviewed the project amendments and established priority for the 5<sup>th</sup> year proposed projects. She noted that Marylyne Lane (Page 91 on proposed plan) is partially funded but upon review with Public Works leadership, staff recommends funding the project. Budgeting staff is projecting revenues to increase over the next few years. Mrs. Borquez concluded the presentation and offered to answer questions on the proposed plan.

Member Pham asked if there were statutory deadlines in which programmed funds had to be expended on projects and Mrs. Borquez answered that she was not aware of such deadlines. She stated that if a project does not move towards completion, then the project is reevaluated and potentially cancelled.

Member Snider asked if projects for Budget Years 2012-2013 were completed within budget. He indicated interest in knowing how many projects were completed as well as if the projects were completed within the scheduled time and budgeted funds.

Member Pham asked if budget carryover amounts should be identified on future plans.



Mrs. Borquez stated that she would consult with the Public Works Area Engineers and leadership to see what information could be gathered and provided at a later date.

Member Pham remarked that the proposed plan reflects almost equal funding for improvement and maintenance projects but commented that as more roadways are constructed, a greater amount of funding will need to be applied towards pavement preservation.

Member Fabris asked if there were any immediate plans to construct Queen Creek Road (Pima Road) from Pinal to Maricopa Counties as it could be a good east-west connection for San Tan Valley. Jeff Stolze suggested that answer would be best addressed by Pinal County Community Development Department but thought that half-street improvements would be stipulated when Fulton Homes develops in the area. Celeste Pemberton stated that the several east-west connections for the San Tan Valley area were previously designed but shelved when the economy declined in 2005-2006 and impact fee revenue dwindled.

Hearing no other questions or discussion on the proposed plan, Chairman Louis called for a motion.

Member Vangilder made a motion to approve the 2014 Five-Year Transportation Improvement and Maintenance Program for Budget Years: 2013-2014 through 2017-2018 as presented and Member Prechel seconded the motion. The motion passed unanimously.

X. Discussion/Election of Chairman and Vice-Chairman pursuant to Article IV: Officers and Duties, Section 3 of the Pinal County Transportation Advisory Committee Bylaws

Member Prechel made a motion to nominate Kevin Louis as Chairman of the Transportation Advisory Committee and Member Fabris seconded the motion. The motion passed by majority vote (Chairman Louis: Nay :).

Member Vangilder made a motion to nominate Maxine Brown as Vice-Chair of the Transportation Advisory Committee and Member Fabris seconded the motion. The motion passed unanimously.

XI. Discussion on the process to amend the Pinal County Transportation Advisory Committee Bylaws pursuant to Article VII: Amendments of Bylaws

Kathy Borquez stated that she will be recommending minor administrative changes to the Transportation Advisory Committee Bylaws. She will work with Vice-Chair Brown who is tasked with overseeing amendments to the bylaws.


