ADDENDUM 1

The purpose of this addendum is to answer responder questions that were asked in writing. Addendum 1 answers questions that have been asked prior to noon on April 18, 2016. Additional addendum(s) may follow if additional questions are asked.

QUESTIONS AND ANSWERS

1. Q: I have a storage facility in a different location from my office where I run dispatching. The office is run out of my home. Is that ok or do I need to rent a office?

A: You are not required to rent an office so long as you meet the response times and release requirements in the RFP.

Section 2.7.1(h) of the RFP requires that the storage facility be accessible for releasing vehicles between 8am and 5pm Monday-Friday and between 8am and noon on Saturday. Therefore you must be able to release vehicles from the storage facility and not require citizens to go to an alternate location to release their vehicles.

In addition Section 2.7.1(h) states that if the storage facility is a satellite facility which may not have employees present during those accessibility hours, the Contractor must be able to respond to citizen or PCSO calls within 30 minutes. This means the Contractor must be able to get to their storage facility within the 30 minute time requirement to assist citizens in the release of their vehicles.

1. Q: I have a question in relation to the wall. Is the height measured all the way up including the barb wire or just to the top of the fence?

A: The height is measured to the very top of the barrier which would include any barbed wire, razor wire, etc. if applicable, on the top. No area of the enclosed perimeter shall be less than 6 ft.

2. Q: Is this for all of Pinal county or just certain sections? Also if you are a selected tow company do you go on normal rotation or a back up rotation?




