How Does Road Name Change Occur?

Pinal County Planning and Development Service Department personnel shall determine the need to re-name an existing street or right-of-way or an upcoming street included in a proposed subdivision.

Proposed renaming can be initiated by the Board of Supervisors or by citizen petition.



Petitioning for Road Name Change



Contact Addressing Section in Community Development for information regarding the road name change process and for an evaluation of proposed new road name prior to generating a petition. A citizen petition must contain signatures of at least 51 percent of the residents or land owners with frontage on or addresses assigned from the street of the proposed name change.

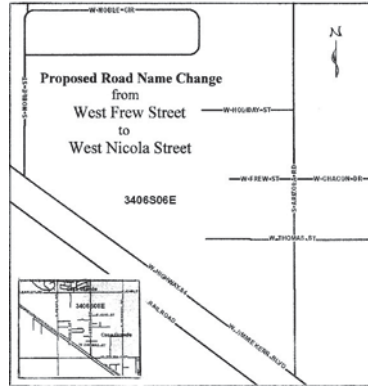
The petition must be brought to Building F in Florence to Addressing to be verified; if accepted, a non-refundable fee of \$1150.00 must be paid and the Road Name Change case is established.

After the Petitions Are Filed and Filing Fee is Paid, Then What Happens?

The Community Development Department shall make a reasonable attempt to notify the property owners/residents of the proposed name change.

The Community Development Department will create a map showing the existing road name and the proposed name change.

The map will be published two times in a local



newspaper that has a circulation in the area of the proposed name change.

Public Input is Sought

The public is given two weeks from the last publication date to file petitions objecting to the proposed name change. The signatures on the petition must belong to residents or property owners with frontage on road undergoing the road name change process.



Public Hearing is Held

A public hearing will be held by the Board of Supervisors on the proposed name change after giving at least 15 days of notice.



That notice of public hearing shall be given by the publication once in a newspaper of general circulation in the area of the proposed name change.

If the Road Name Change is Approved

Upon approval by the Board of Supervisors, the Addressing Section in Planning and Development Services will mail out written

notice to the residents/property owners affected by the name change stating the new address.



After approval of the name change by the

Board of Supervisors, any subsequent proposed name change will not be considered for a period of five years.

Costs

The cost of filing a petition for a Road Name Change is a non-refundable fee of \$1,150.00.
